### **PROCEEDINGS:**

No objections were lodged against the composition of the Court.

Having heard the evidence and representations of the person/s present, the court found as follows:

### **FINDINGS OF THE COURT:**

1 – That Wyatt Avis is guilty of contravening SSR 257 of the 2011 MSA Motocross Regulations read with GCR 113 (xiv) and GCR 114.

2 – That the entrant of the rider is cautioned and that the entrant's attention is drawn to GCR 115.

3 – That Wyatt Avis's licence is suspended for six (6) months. This sentence is suspended for twelve months on condition that the competitor is not found to have contravened SSR 257 of the 2011 MSA Motocross Regulations, GCR 113 (xiv) and/or GCR 114.

The penalty is effective immediately (17<sup>th</sup> March 2011) and will be valid until 17<sup>th</sup> March 2012

All parties are reminded of their right to appeal.
