## MSA COURT OF ENQUIRY 1059

The President introduced himself and the Court Members. There were no objections to the composition of the Court.

The Court held the view that the competitors should be afforded the opportunity of addressing the Court on the alleged Contravention of GCR 172 (iv)

The Court was informed that witnesses Charl Spies and Johann Spies had tendered their apologies and informed the Court Scribe that they would not be attending the hearing. The Court were presented with statements from the witnesses

The Court considered the evidence, by Mr. Izak Maritz and Mrs. Maritz, Mr. Adolf Menezes and Mr. Gerhard Du Plessis. In considering the elements and evidence, the Court takes cognisance of the provisions of GCR 211 and GCR 220.

### Findings:

The Court after having heard the evidence and the submissions, reprimands Mr. I Maritz for using foul language in close proximity to spectators. Mr. I Maritz is also further given a suspended sentence which suspension is suspended for a period of one year on condition that he is not found to contravene the provisions of GCR 172 (iv). The suspension is to run from the date of the publication of these findings up to and including 17<sup>th</sup> March 2012.

The Court after having heard the evidence and the submissions finds that Mr. A Menezes and Mr. Z Menezes are hereby warned to be more diligent in future whilst competing regarding spectators who may be in close proximity to the vehicle. The Organisers are hereby requested to ensure that spectators are kept back from all obstacles in the future.



The Court after having heard the evidence and the submissions finds that Mr. P Van Der Berg the appointed COC on the day contravened GCR 172(iv) by not arriving at the event is hereby given a 6 month suspension. Mr. Van Der Berg is requested to hand over his official's card to MSA. The suspension is to run from the date of the publication of these findings up to and including 17<sup>th</sup> September 2011.

Costs to the amount of R300 are hereby awarded against Mr. Pierre van der Berg

These findings were not read at the Court Of Enquiry 1059
