### ABSENT WITH APOLOGY:

No objections were lodged against the composition of the court and all parties confirmed receipt of their notices regarding the enquiry.

### FINDINGS:

After having heard all the evidence and submissions by all parties, in particularly that of the Clerk of Course, Mr Tony Grifo, the court finds that Mr Micouris was agitated but not aggressive or abusive. Mr Andy Micouris questioned the competence of the officials with regards to the interpretation of the Drag Racing rules and regulations. The matter should have been discussed in private and not in front of competitors and other officials.

The court further finds that the relevant matter should have been resolved on the day of the event.

The court imposed the following sentence:

Mr Andy Micouris received a six (6) month suspension to officiate at any event, suspended for six (6) months. In addition Mr Micouris is cautioned for future events.
