## INTRODUCTION

The Court President introduced himself and the Court members, and no objections were lodged against the composition of the court.

## FINDINGS

After hearing all the evidence and allowing each attendee sufficient time to voice their concerns and views regarding the incident, the Court finds as follows:

- 1) The Promoter did not follow correct procedure with regards to final instructions as per GCR 141 (vi).
- 2) The COC and Stewards did not follow correct procedure with regards to protests and appeals as per GCR Part IX and X.

In terms of its findings the court rules as follows:

- 1) Both COC and Stewards are reprimanded for their actions and the manner in which they handled the situation.
- 2) The Court suggests that steps are put in place for the 2016 event, so that situations like these will be avoided for future events.
- 3) The Court upholds the fine imposed by the officials issued to Team Roberts Racing Rallye Team.

All parties are reminded of their rights in terms of GCR 212 (B).
