The court president introduced himself and the other court member. There were no objections to the composition of the court. After having heard the evidence presented, the court finds as follows:

1. The court was satisfied that there were raised voices in the MRC offices which inflamed the situation, when in fact calmness would have had a better effect.
2. This was further compounded by the competitor's lack of knowledge of the rules.

Based on the above, the court makes the following findings:

1. Penalty of exclusion given by the Clerk of the Course remains in effect.
2. The competitor (by his own admission) is instructed to make himself more au fait with the rules.
3. It is also recommended that the Clerk of the Course notify competitors personally of any infringements in writing.

No costs to be awarded.
