Court President













The court president introduced himself and the court members. There were no objections to the composition of the court.

The Hearing

The court was informed that the MSA Steward, Mr. Piet Swanepoel, had tendered his apologies and informed the court scribe that he would not be attending the hearing.

The court afforded the opportunity to Mr. Rheeder of addressing the court on the alleged contravention in terms of GCR 172.

The court then heard statements from all parties present and considered the evidence of the aforementioned witnesses. In considering the elements and evidence, the court takes cognisance of the provisions of GCR 211 and GCR 220.

Findings:

After having heard the evidence and the submissions by all parties present, the court finds as follows.

- Competitor Rheeder admitted to the use of foul language. While subjective, it is clear that there was an altercation between Competitor Rheeder and Mr. Vic Rich. Competitor Rheeder is accordingly given a one (1) race meeting ban, suspended for the first three (3) national race meetings of 2013. Said ban will therefore only come into effect should he be found guilty of another infringement in terms of GCR 172 during the intervening period.
- 2. The court orders Competitor Rheeder to pay costs of R500 to MSA in connection with this hearing.
- 3. The court finds the Clerk of Course's decision for the pace car to be parked in the front of the pit entrance to have been incorrect. He is reprimanded in this regard.
- 4. Even though Mr. Vic Rich was a spectator at the event, notwithstanding his years of involvement in motor sport and his link to the meeting via the use of his pace car, the court finds his actions pertaining to the matter concerning. Mr. Rich is hereby reprimanded for his actions. Should a matter of a similar nature arise in the future, these findings will be taken into consideration.
